INVESTMENT OBJECTIVE

The Winton Diversified Macro Strategy seeks to identify and exploit opportunities using advanced statistical and pattern recognition techniques. The strategy employs trading signals in futures and OTC markets across geographies and asset classes along with strong risk management processes that seek to achieve stable returns over the long-term. The fund excludes commodities.

MONTHLY COMMENTARY

Equities built on their April gains in May, with the information technology sector leading the MSCI World to rise a further 4.8%. Markets related to China underperformed, however, with the Hang Seng and HSEI indices ending the month lower. Returns in fixed income were mixed, with yields rising on US Treasury bonds, Japanese government bonds and German bunds, while falling on US Treasury notes, Italian BTPs and UK gilts. In currencies, the US dollar strengthened against the Japanese yen and British pound, but weakened against the euro.

The fund's negative return during the month was the result of the global defensive positioning and losses were recorded in stock indices, currencies and fixed income. The negative performance in stock indices was due to the fund's global short positioning in the equity allocation with Europe and Asia being the most painful regions. Losses in currencies were encountered mainly on exposures to the euro, Australian dollar and Norwegian krone. In interest rates, the negative P&L came from the U.S and German long-term position.

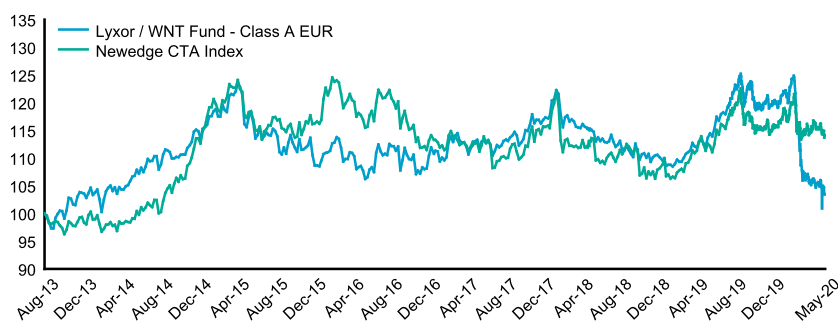

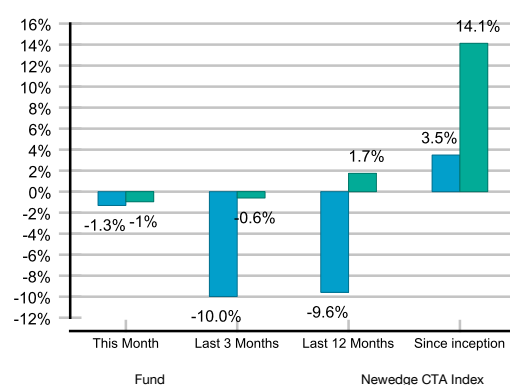
